GUJARAT EDUCATIONAL SERVICE CLASS-II (ADMINISTRATIVE BRANCH)

1. These rules may be called the Gujarat Educational Service Class-II (Administrative Branch) Recruitment Rules, 1969.

2. Appointment to the post of Gujarat Educational Service Class II (Administrative Branch) under the Director of Education shall be made either -

i) by promotion of persons of proved merit and efficiency in the Gujarat Educational Service, Class-III (Administrative Branch)

ii) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate must -

a) be not more than 30 years of age;

b) have bachelor's degree in Arts, Science, Commerce, Agriculture of Law of a statutory Indian Foreign University;

c) have passed B.T./B.Ed. or an equivalent Degree or diploma of recognised university;

d) have about five years teaching inspecting or administrative experience after obtaining the B.T./B.Ed. or equivalent qualifications and

e) have adequate knowledge of Gujarati;

Provided that the upper age limit may be relaxed in case of Gujarat Servants in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

4. Appointment by promotion and by direct selection shall be made in the ration of 1 : 1.

5. The candidate appointed by direct selection shall be on probation for period of two years.

The selected candidate shall be required to pass during the period of probation departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the rules Government in the behalf.

7. The candidate appointed by direct selection also have to under go post recruitment training as may be prescribed by Government and to pass an examination held after completion of training, with in two chances. Failure to pass the examination within the two chances will render him liable to discharge from service without notice.
